4. First-aid measures

6. Accidental release measures

Methods and materials for containment and cleaning up

Do not get water on spilled substance or inside containers. This material is classified as a water pollutant under the Clean Water Act and should be prevented from contaminating soil or from entering sewage and drainage systems which lead to waterways.

Large Spills: Stop the flow of material, if this is without risk. Following product recovery, flush area with water.

Small Spills: Clean surface thoroughly to remove residual contamination.

7. Handling and storage

Precautions for safe handling

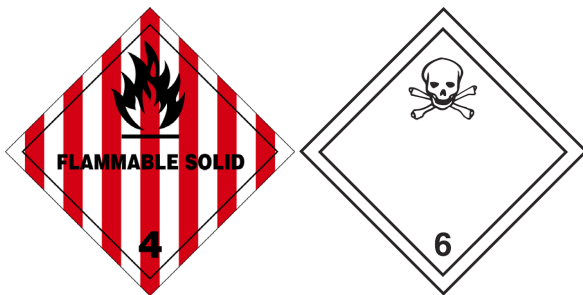

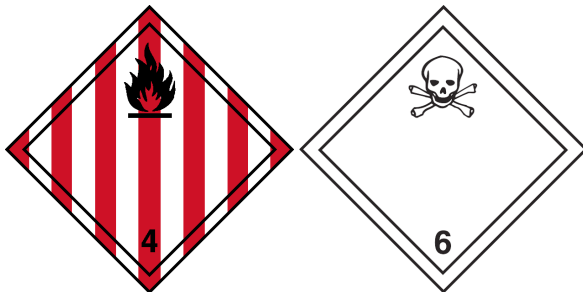

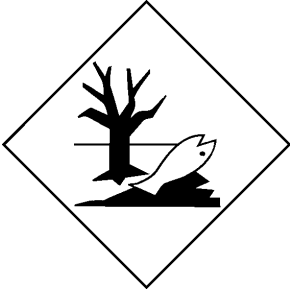
